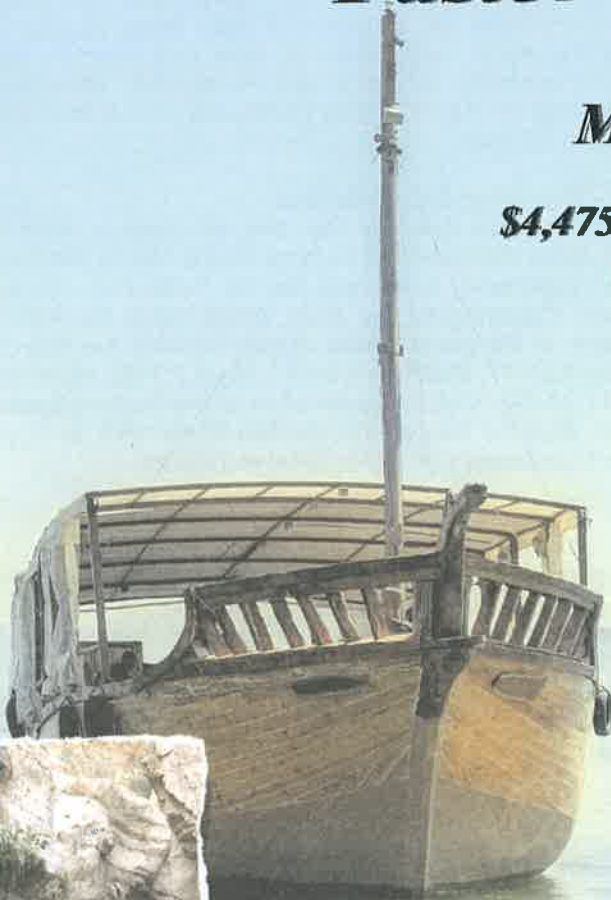

**Day 1 – March 11 - Monday: Flight**  
Overnight flight from USA to Tel-Aviv.

### **Day 2 – March 12 - Tuesday: Arrival – Jaffa – Tel Aviv**

Upon arrival at Ben Gurion airport you will be met and assisted by a Coral Travel & Tours representative at the airport. Meet your guide and drive to **Jaffa**. Jaffa has been known in the bible as Joppa and is considered the world's oldest port and the place where the prophet Jonah set sail for Tarshish. After a short drive through Tel Aviv check into your hotel. Dinner and overnight: Hotel in Tel-Aviv.

### **Day 3 – March 13 - Wednesday: Caesarea - Mt. Carmel – Megiddo – Sea of Galilee**

After our Israeli breakfast travel via the Sharon Plain to **Caesarea**. Caesarea was the seat of the Roman Procurator of the Judea in the time of Christ and the place St. Peter converted the centurion Cornelius (Acts 10:24). Explore the Roman theater and the aqueduct, and view the ruins of Roman, Byzantine and Crusader times. Continue on to **Mt. Carmel**, to the **Mukhraka**, the site where Elijah challenged and defeated the 450 prophets of Baal (King 18:20). Continue on to **Megiddo**, the fortress city of King Solomon, later built upon by King Ahab. The books of Daniel and Revelation will come alive as we study about the final Battle of Armageddon (Revelation 16: 14-19). Drive to Tiberias on the Sea of Galilee. Dinner and overnight: Hotel in Tiberias.

### **Day 4 – March 14 - Thursday: Sea of Galilee**

The day starts with a **boat ride on the Sea of Galilee**. Visit the **Mount of Beatitudes**, where Jesus delivered the Sermon on the Mount (Matthew 5:1-12). For lunch we'll have an opportunity to sample the St. Peter Fish (on your own). Visit **Magdala**. Then, visit **Capernaum**, the town Jesus made his home after leaving Nazareth. Capernaum is the place where Jesus recruited the first of His disciples (Matthew 4:13, Luke 4:31-37, Matthew 8:14-17, Mark 2:1-12, Matthew 8:5-13, Mark 5:21-43, Matthew 11:23-24). Visit the excavation of the Ancient Synagogue and the House of St. Peter. End the day at the **Jordan River** with an opportunity to be baptized (optional). Dinner and overnight: Hotel in Tiberias.

### **Day 5 – March 15 - Friday: Golan Heights**

After breakfast drive to **Tel Dan**, an important biblical city and a breathtaking nature reserve. The bible mentions the city few times: "from Dan to Beer Sheba". You then visit the **Banias**, site of the ancient **Caesarea Philippi**. It is here that Peter made his confession of faith in Jesus (Matthew 16:13). Continue to **Mt. Bental** for a panoramic view of the Golan Heights. Return to Tiberias. Dinner and overnight: Hotel in Tiberias.



**Day 6 – March 16 - Saturday: Bet She'an – Jordan Valley - Jerusalem**

After breakfast leave the Sea of Galilee and drive to **Bet She'an**. Recent excavations have disclosed the impressive ruins of the country's largest city from the Roman and Byzantine periods, which was destroyed by an earthquake in 749 CE. Continue to **Ein Harod**, the site of Judge Gideon (Judges 7: 1-25). Drive along the **Jordan Valley** past **Jericho**, believed to be the world's oldest walled city, and the first city taken by Joshua when the Hebrews returned from Egypt – "and the walls fell down". It was also the site of the **Mount of Temptation** (Mark 1:13). Drive to Jerusalem. Pass the traditional site of the Inn of the Good Samaritan. Enter the city of **Jerusalem** in the traditional way and view the city from **Mt. Scopus**. Dinner and overnight: Hotel in Jerusalem.

**Day 7 – March 17 - Sunday: Massada – Ein Gedi – Qumran – Dead Sea**

After breakfast depart from Jerusalem to the Dead Sea and visit **Ein Gedi**, an Oasis on the Dead Sea shore. Near the 200-meter-high waterfall is a cave where David had his famous meeting with King Saul (First Samuel 24: 1-23). A walk around the reservation confirms that Ein Gedi is one of the most beautiful reservations in the world. Drive along the shores of the Dead Sea to **Massada**. Ascend Massada by cable car. Massada is the site of the most dramatic act in Jewish History. Explore the ancient excavation of Herod's Palaces, the bath-house, the storerooms, the Ramp, and the oldest Synagogue in the world. Continue to **Qumran**, where the 2000 years old Dead Sea Scrolls were found. Continue on to the **Dead Sea** shore for an afternoon "float" at the sea. Return to Jerusalem. Dinner and overnight: Hotel in Jerusalem.

**Day 8 – March 18 - Monday: Jerusalem**

After breakfast we'll ascend the **Mount of Olives** (Matthew 24:3, Luke 21:37) for a breathtaking panoramic view of the old city of Jerusalem. Walk along the **Palm Sunday Way** to the **Garden of Gethsemane** (Matthew 26:36-46, Luke 22:39-45, Mark 14:32-42), where Jesus spent the last night before he was arrested. Walk along the **Kidron Valley** and see the **Tombs of Absalom, Zachary and James** to the **Ophel**. Visit the **Davidson Center (Southern Wall excavations)**. Drive to the western side of the city and visit the **Israel Museum**, the **Shrine of the Book** (where some of the Dead Sea Scrolls and Bar Kokhva letters are exhibited), the **Holy Land Model**. Continue on to **Yad Vashem**, the Holocaust Museum. Dinner and overnight: Hotel in Jerusalem.

**Day 9 – March 19 - Tuesday: Ella Valley - Jerusalem**

The day starts with a drive out of Jerusalem past Bet Shemesh and Zorah in the Soreck Valley to the **Ella Valley**, where David fought Goliath. Return to Jerusalem and enter the Old City. Visit the **Upper Room** (Matthew 26: 17-25). Visit the **Cardo** and the **Broad wall** in the Jewish Quarter. Visit the **Rabbinical Tunnel** (Western Wall Tunnel). Dinner and overnight: Hotel in Jerusalem.

**Day 10 – March 20 - Wednesday: Jerusalem**

This morning drive to **Mt Moriah** (Luke 2:46-48, John, 8:1-11, Mark 13:1-2, Matthew 27:51). Walk up to the Temple Place and view the **Dome of the Rock** and the **El Aqsa Mosque**. Continue on to **St. Anne's Church**, which is a fine example of Crusader architecture and the **Pools of Bethesda**. Visit the **House of the High Priest Caiphas**. Visit the **Church of Peter in Gallicantu** (Matthew 26:31-35). This is the place where Peter denied His Lord 3 times. End the day at the **Garden Tomb**. Farewell dinner. Overnight: Hotel in Jerusalem

**Day 11 – March 21 - Thursday: Jerusalem – Tel Aviv - USA**

Transfer to the airport for your flight back to the USA. Arrive the same day.

## **GENERAL EXCLUSIONS**

### **Insurance benefits are not payable for any loss due to, arising or resulting from:**

1. suicide, attempted suicide or any intentionally self-inflicted injury of You, a Traveling Companion, Family Member or Business Partner booked to travel with You, while sane or insane;
2. an act of declared or undeclared war;
3. participating in maneuvers or training exercises of an armed service, except while participating in weekend or summer training for the reserve forces of the United States, including the National Guard;
4. riding or driving in races, or speed or endurance competitions or events;
5. mountaineering (engaging in the sport of scaling mountains generally requiring the use of picks, ropes, or other special equipment);
6. participating as a professional in a stunt, athletic or sporting event or competition;
7. participating in skydiving or parachuting except parasailing, hang gliding, bungee cord jumping, extreme skiing, skiing outside marked trails or heli-skiing, any race, speed contests, spelunking or caving, or scuba diving if the depth exceeds 120 feet (40 meters) or if You are not certified to dive and a dive master is not present during the dive;
8. piloting or learning to pilot or acting as a member of the crew of any aircraft;
